1. Call to Order

President Paul Overocker called the meeting to order at 6:34 p.m.

2. Approve Agenda – Bryan S made a motion to approve the agenda; Angi H seconded the motion and the motion passed unanimously.

3. Approve Minutes – Bryan S made a motion to approve the meeting minutes from June 2021; Angi H seconded the motion and the motion passed unanimously.

4. Financial Update – Angi K was able to get her computer fixed and is wrapping up the fiscal year; awaiting final numbers from golf tournament as more checks are still coming in. Financials were sent out through the end of May 2021 – Bryan S made a motion to approve those financials; Angi H seconded the motion and the motion passed unanimously.

6. New Business

A. Start Date/Registration: The plan currently is to begin the season on September 20th, 2021 – for traveling teams, practices will be one to two days a week to accommodate for those players/families who also participate in a fall sport. Kylene is working with SportsEngine to complete a registration link for August 9th opening date. November 6th is Try Hockey For Free and the association is looking at participating again this year after taking last year off due to Covid. The association is looking at a start date for mites on October 30th. Mites will continue to have waived registration fee due to continued success of golf tournament. Pick up dates for raffles were discussed on 9.13.21 and 9.15.21 – in addition to an All-Association Zoom meeting on 9.9.21. The association is asking that all traveling players are signed up by 9.18.21 to assist in ordering jerseys, and that all move-up forms are due by 9.5.21 to ensure they are in prior to board meeting and jersey order. Angi K made a motion to keep the cost for playing and fundraising requirements the same as they were in the 2020/2021 season; Bryan S seconded that motion and the motion passed unanimously.

B. Try-Outs: Number of kids at each level and details discussed in regard to try outs. At this time the association is planning to do try-outs for traveling teams the week before MEA. This will assist in tournament sign ups, coaching assignments and logistics moving forward.

C. Jerseys: The plan is to place the large/bulk jersey order no later than September 27th. Warm ups and colors discussed, logo discussed, names will be on both home and away. The association is going with the city scape design and there will be only one set of socks vs. in previous years having a home and away sock.

D. Try Hockey For Free: Discussed previously – the association would like to get back to providing this event to the community. The date for the fall is November 6th, 2021. Plan to get the flyer out to schools for promotion. Troy will also utilize the various social media to promote this event and is working with Nancy Schnable at Discover Austin to promote AYH as much as possible.
