KY State Clinic 2022-

Score Tracking-

Angela Dickey has been tracking scores to assure that all attending our KY State Meets are eligible and are meeting the required score, are in the correct levels according to what level they competed last meet season, and to also assure that

they have meet the declaration date. We asked that she reach out to us for help if needed and Jason will reach out to any gyms that have a level mistake and let them know what procedures they need to follow. At this time she has one discrepancy and a few that have not meet the needed all around score.

Open Scoring-PER USAG R & P=

An Open Scoring question was brought up from a judge from another state that was in KY judging one of our KY meets, she stated that we were not supposed to be doing Open Scoring.

Open Scoring is defined as either electronically flashing each judges score by writing each judges score on each athlete's competitor card.

- It is required at Level 10 Nationals and Level 9 Eastern/Western Championships.
- Allowed at Regional Championships, determined by the Regional Administrative Committee.
- Allowed at Optional State Championship, determined by the State Administrative Committee.
- Allowed at Optional Invitational's, at the discretion of the meet director.
- NOT ALLOWED AT ANY COMPULSORY MEET, INCLUDING COMPULSORY STATE CHAMPIONSHIPS.

Jason will reach out for more clarification regarding invitational's and notify the meet directors of our state meets and our last KQ meets as to what to do.

New Venue for our KY State Meet Level 2-3 and Xcel Bronze and Silver-

It was brought to our attention that due to rising COVID rates, the Fayette County public school system will be canceling events and not renting out their facilities. Legacy has now secured the use of Memorial Coliseum! Shannon Wickel made a motion on Thursday February 10, 2022 to allow this venue change. Debbie Klotz 2nd the motion.
