Review Minutes from last meeting, Feb 24, 2020. – Cuddy motioned to approve, Matt Moss second. Unanimous. Approved

Brett – Treasurer Report. Feb 2020: Deposit \$13673.36, Withdrawal: \$12699.21. Mar 2020: Deposit: \$7460, Withdrawal: \$1853, April Deposit: \$0, Withdrawal: \$14.50, May 2020 Deposit: \$257, Withdrawal: \$78.19, June 2020 Deposit: \$0, Withdrawal, \$78.19. League Operating June 2020: \$23574.95. Refunds will be sent out through paypal. Team Fee Refunds, discuss fall season before final decision.

Elections should have been in May. 2020 Board Elections & Voting will be scheduled as follows: Nominations: July 20, 2020 to Aug 3, 2020. Aug 4, 2020 board to announce nominees. Voting: August 10 – 16, announce winners at board meeting on Aug 17. Voting will be done electronically based on Spring Registration.

Kevin Hill: Emails going to players for paypal and coaches for where they want their team fee refunds to go to.

Neon Classic: Currently planning it as “normal.” Dates Oct 24-25, 2020. \$300 entry fee. Currently 6 teams registered. We will need volunteers to help plan and for weekend of tournament.
