• **Tournaments:**

○ **Motions**

- Mike motioned to increase tournament entry fee from \$400 to \$450, Dan 2<sup>nd</sup>, all in favor, motion passed.
- Grant motioned to increase the tournament director’s pay from \$4,500 to \$5,000 with a bonus potential of \$1,000 if tournament budget is met.

• **Concessions:**

- Concessions will now stand on its own and not be grouped with tournaments. No money from concessions will be used to pay field crew, checks will be mailed.

- **Travel:**
  - Budget is on hold
- **SSL:**
  - Motions
    - Dan motioned to increase player fees for 10/12/14/HS to \$300 for summer 2026, Mike 2<sup>nd</sup>, all in favor, motion passed
    - Grant motioned for all SSL teams to play 1 night of double headers and have 1 night of practice, Eric 2<sup>nd</sup>, all in favor, motion passed
    - Coaches get players fees back, motion not needed since that is already in place.
- **Lil Peppers:**
  - Motions
    - Grant motioned for a \$20 fee to be added to all late registrations for Lil Peppers, SSL and travel, Kelly 2<sup>nd</sup>, all in favor, motion passed.
    - Dan motioned that MAGFA allow sponsors on Lil Pepper's jerseys, Mike 2<sup>nd</sup>, all in favor, motion passed.
    - Mike motioned that players are allowed to drop out within the first week of the season to get a refund, after that no refund is given, Ryan K 2<sup>nd</sup>, all in favor, motion passed.
    - Ryan A motioned that only the head coach will get paid for coaching, Dan 2<sup>nd</sup>, all in favor, motion passed.
- **Fall Ball:**
  - Motions
    - Ryan K motioned to increase the registration fee \$25 for all ages, Dan 2<sup>nd</sup>, all in favor, motion passed.
- **Building:**
  - Budget is on hold
- **Sponsorship:**
  - Motion
    - Mike motioned to hire a marketing person that would be paid 10% of what they bring in from new sponsors and 5% from what we receive from existing sponsors, Eric 2<sup>nd</sup>, all in favor, motioned passed.
- **Paid Positions:**
  - Motions
    - Ryan A motioned to adjust equipment manager's stipend to \$2,500, Dan 2<sup>nd</sup>, 8 voted yes, 1 voted no, motion passed.
    - Kelly B motioned to have the Social Media Coordinator's stipend be \$2,000, Grant 2<sup>nd</sup>, all in favor, motion passed.
    - Will remove tryout coordinator's stipend, position will no longer be needed going forward
- **Other Discussion Topics:**
