

**RELEASE OF LIABILITY, INDEMNIFICATION, AND MEDIA AUTHORIZATION
(Sacramento Republic FC)**

In consideration of being allowed to participate in on-field or other promotional activities conducted by or at the direction of Sac Soccer USL, LLC, dba Sacramento Republic FC ("SSU"), the undersigned hereby agrees as follows: I hereby expressly, unconditionally and irrevocably acknowledge the presence of a significant risk of harm associated with my participation in promotional activities, and I assume all risks and danger (known and unknown) of personal injury to me, and of any damage to or loss of any of my property, arising out of or in any way relating to my presence on or about the playing field or other area where such promotional activities are conducted, whether occurring prior to, during or subsequent to my participation in or observance of the promotional activities. I further agree that, to the fullest extent permitted by law, SSU, United Soccer Leagues, LLC, their respective affiliates (including, but not limited to, Sac Soccer & Entertainment Holdings, LLC), and their respective employees, agents, officers, members, managers, shareholders, directors, contractors (including, without limitation, Sacramento Republic Football Club, LLC and SRFC Personnel Group LLC), and other representatives (collectively, the "**Released Parties**") shall have no liability for any such injuries, losses or damages. Without in any way limiting the foregoing: (i) to the fullest extent permitted by law, I hereby expressly, unconditionally and irrevocably waive and release any claim or cause of action that I may have against any of the Released Parties arising out of any such injuries, losses or damages, even if arising out of the negligence of such Released Party. I also agree, to the fullest extent permitted by law, to indemnify, defend and hold harmless each of the Released Parties from and against any and all claims, causes of action, losses, liabilities, actions and/or judgments which relate to such injuries, losses or damages, or to injuries, losses or damages that I cause to others present on or about the area(s) in which the promotional activities occur.

I agree that prior to my participation in any promotional activities, I will inspect the facilities, equipment and area where such promotional activities are being conducted and, if I believe any of them are unsafe, I will immediately advise the person supervising the promotional activities. I also agree to comply fully with all stated and customary terms and conditions for participation in such promotional activities. I acknowledge and understand that my participation in such promotional activities may involve risk of serious injury or death, including economic losses, which may result not only from my own actions, inaction or negligence, but also from the actions, inaction, or negligence of others, the condition of the facilities, equipment, or areas where the event or promotional activities are being conducted, or these types of promotional activities in general. I warrant that I am in good health and have no physical condition that would prevent, or present an undue health risk from, participation in such promotional activities.

I hereby grant to SSU the unrestricted right to use, adapt, reproduce, display and publicly air, in any medium throughout the world in perpetuity, my name, visual likeness, voice, and biographical data, in whole or in part, in connection with any advertising, promotional or marketing activities of SSU or its affiliates, without notice, review, approval, or compensation to me. Without limiting the foregoing, I hereby authorize and give my full consent to SSU and its affiliates to copyright and/or publish any and all photographs, videotapes and/or film in which I appear while participating in the promotional activities or otherwise while attending the event at which they occur. I further agree that SSU and its affiliates may transfer, use, or cause to be used these photographs, videotapes, or films for any exhibitions, public displays, publications, commercials, art and advertising purposes, and television, radio or internet programming, without limitations or reservations.

The language in all parts of this instrument shall be in all cases construed simply according to its fair meaning and not strictly against either the undersigned or any Released Party. Wherever possible, each provision of this instrument shall be interpreted in such a manner as to be valid under applicable law, but, if any provision of this instrument shall be invalid or prohibited thereunder, such invalidity or prohibition shall be construed as if the legally impermissible portion of such invalid or prohibited provision had not been inserted herein and shall not affect the remainder of such provision or the remaining provisions of this instrument.

I have read this Release of Liability, Indemnification, and Media Authorization, fully understand its terms, understand that I have given up substantial rights and undertaken substantial obligations by signing it, and sign it freely and voluntarily without any inducement. I declare that I am over the age of 18 years (or, if not, a parent/guardian must sign below), and that I am otherwise fully competent to sign this instrument on my own behalf.
