## **TOURNAMENT INFORMATION**

**Arrival:** **Lakeville North High School:** Teams and Spectators should enter through Door #1.

**The doors will be open at 4:00p on Friday and 8:00a on Saturday.**

**Parking:** **Due to a home Lakeville North High School football game on Friday, 10/10, all buses are asked to park at the North Cross Church just one block north of Lakeville North High School (19400 Ipava Avenue, Lakeville, MN 55044). We apologize for any inconvenience this may cause and appreciate your understanding.**

**McGuire:** Teams should enter through Door #16, and spectators should enter through Door #13.

**The doors will be open at 4:00p on Friday and 9:00a on Saturday.**

**Admissions:** Adults: \$10.00      Seniors & Students 5 & Up: \$6.00      Children Under 5 & Bus Drivers: Free

**\*Cash or Credit Card will be accepted.\***

**Concessions:** There will be concessions available throughout the day with a wide variety of options. **No outside food will be allowed inside the gymnasium or in the commons area.** Do not bring any electrical appliances (crockpots, toasters, etc.); they are a safety risk and not allowed. Please communicate this information to your program, and we appreciate your willingness to utilize the great variety that will be available in the Lakeville North Volleyball concessions. Every HEAD coach will receive one complimentary food voucher for concessions.

**Schedule:** The official online schedule will be sent out next week, and there will also be QR Codes posted around the building for access to the schedule.

**Trainer:** There will be an on-site Athletic Trainer staffed for the duration of the tournament on both days. There is a chance that we may not have one on site Friday night due to all of the football coverage across the state. It is encouraged that each team/player provide their own injury prevention (pre-wrap, tape, ankle brace, etc.) items to use.

**Locker Room:** Locker rooms will be available for use at both sites. Locker rooms will be unsupervised and unlocked. Lakeville North and staff are not responsible for lost, stolen, or damaged items. Do not leave any items unattended in this area at any time.

**Warm-Ups:** There will be a 10-minute warm-up (2-4-4) for every match, with the serving team on the net first.  
**Warm-up balls will be provided.**

**Personnel:** R1s and table workers will be provided.  
**We ask that each team provide a line judge for each of their matches.**

**Lounging:** Teams at Lakeville North High School may lounge only in the commons. Teams will not be allowed to lounge on any carpeted areas on the upper track, or outside the gymnasiums.  
 Teams at McGuire Middle School may lounge down hallways #1 or #5 only. Tables inside the cafeteria will remain reserved for guests who have purchased food at the concessions.
