Club Fees & What's Included

- **Club Membership:** \$3,600 for the season (covers coaching staff, conditioning sessions, equipment, facility rental, and tournament registrations).
- **Gear / Acceptance Fee:** \$400 due upon committing to RVA (covers player uniforms and apparel: 3 jerseys, 1 hoodie, 1 practice shirt, 1 pair of slunks, 1 RVA backpack).

Not included: USAV/CHRVA membership, AAU membership, transportation, and hotel accommodations.

Payment Method

- Payments are processed **electronically only**. Checks and cash are not accepted.
- **SportsEngine:** The initial \$400 gear/acceptance payment is paid by credit or debit card via SportsEngine.
- We are also working with **TopSports.com** to enable future online payments by credit card or bank account.
