



## REDS HARTLAND HAUNTED INVITATIONAL Liability Release Form for Team Participants

In consideration of our participation in the Reds Hartland Haunted Invitational Soccer Tournament (hereinafter, "the Tournament") organized by Reds Event, LLC (hereinafter, "Reds Events"), we, the undersigned members of the team (or the parents or guardians thereof), hereby acknowledge and agree to the terms and conditions set forth in this Liability Release Form.

**1. Assumption of Risk:** We understand that participating in the Tournament involves inherent risks and dangers associated with soccer activities, including but not limited to running, jumping, sudden movements, collisions with other participants, or contact with spectators, equipment and facilities. We understand there are dangers arising from adverse weather conditions; imperfect field conditions; participants of varying skill levels; situations beyond the immediate control of the event organizers and other undefined, not readily foreseeable and presently unknown risks and dangers. We acknowledge that all or any of these risks may result in serious injury or illness to ourselves, or damage to our personal property. We understand that these risk may be caused in whole or in part by my own actions or inactions or the actions or inactions of others participating in or organizing the Tournament, and we hereby expressly assume all such risks and responsibility for any damages, liabilities, losses or expenses which we incur as a result of our participation in the Tournament.

**2. Release and Waiver of Liability:** In consideration of being allowed to participate in the Tournament, we hereby voluntarily release, discharge, waive, and relinquish any and all claims, demands, actions, or causes of action that we, our heirs, executors, administrators, or assigns may have against Reds Events, its officers, directors, employees, agents, representatives, volunteers, sponsors, and other participants, from any and all liability, claims, damages, costs, or expenses, including attorneys' fees, which may arise from our participation in the Tournament.

**3. Medical Treatment:** We grant permission to Reds Events and its authorized representatives to seek medical treatment for any of us in the event of an injury, accident, or illness during the Tournament. We understand that we will be responsible for any medical expenses incurred as a result of such treatment.

**4. Compliance with Rules and Regulations:** We agree to abide by all the rules and regulations set forth by Reds Events for the Tournament and to follow the instructions of the Tournament officials and staff.

**5. Team Manager's Responsibility:** We acknowledge that the team manager or designated representative is responsible for ensuring that all team members have read and signed this Liability Release Form.

**6. Agreement to Participate:** We certify that each team member is physically fit to participate in the Tournament. We are aware of no medical or physical conditions that could put any team member at risk during participation.

**7. Severability:** If any provision of this Liability Release Form is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

**8. Name, Image, Likeness:** As a condition of our participation in the Tournament, we hereby grant Reds Events, the event director and host organization a limited license to use our names, images, likenesses, photographs, voices, videos, athletic performances, and biographical and other information, in any media platform or format whatsoever, and to distribute, broadcast and exhibit these without charge, restriction or liability, but only for the purposes of advertising, promoting or documenting the Tournament.
