- I. Call to Order
 - a. Attendance-as reported above

- II. Approve Last Minutes

- a. Motion to approve November and November's Impromptu Meeting minutes were made by Jeff and seconded by Lauren, meeting minutes approved.

III. Financial Reports

- a. Motion to approve September & October financial reports were made by Lauren, seconded by Jeff, financials approved.

IV. Board Business

- a. Baseball/Softball Operational/fields updates

i. Spring

1. **Spring Schedule:** The board reviewed the schedule provided. They discussed the meeting date for March's board meeting and decided to keep the current date.
 - a. **Softball:** Jenny discussed Softball dates with the Board and had changes to the All Star Tournament. She proposed changing the dates to July 27-August 2nd, there were no concerns expressed over this change. The board also agreed to increase the cost of the tournament from \$400 to \$450 per team and Jenny asked that the Sports Engine Tourney be set up by the end of December. Jenny will also create a page on the website for the tournament.
2. **Optional Job Field for Parents:** Jenny confirmed that a field was added for parents to include their occupation to registration as optional. Jenny also advised that the photo waiver is no longer a part of registration and will now be included within the fine print of registration.
3. **Registration Banners:** Jenny confirmed that she will work on having the banners completed. Andrew Ray volunteered to help with the banners at Field 2. The Board also discussed placing registration banners for each Board member's home. The Board approved and Jenny will order the signs.
4. **Registration:** The registration link was sent for review and approval by the Board. Not all members received this, so Jenny will forward it to all Board Members for their review. Once approved, Jenny will push the link out on Facebook and email in early January.
5. **Uniforms:** Jenny is taking an inventory on all uniforms to see what needs to be ordered for Spring. We will keep the same style for rookies. Jenny plans to order uniforms in January and will obtain approval from Andrew and Jessica before ordering.
6. **Equipment:** Andrew and Jeff volunteered to take an inventory on equipment.
7. **Field of Dreams Field Update:** Meeting to be scheduled with Andrew, Mark and Dave with the Township.

ii. Softball Updates:

1. **November Clinics:** Jenny confirmed that the Softball clinics went well.
2. **Coaches:** Jenny shared an inventory of coaches and expressed the need for coaches.

3. **January Clinics:** Softball is setting up times for January Clinics now. Jessica will send over the dates.
