1. Roll Call - Amanda Stearns Meeting called to order by Commissioner at 6:32 PT| 7:32 MT. 2. Approve Minutes - Amanda Stearns

- November 17, 2025 Meeting Minutes- 1 minor correction to add Sun Valley to the attendance. Cori (Lake City) presented 1st motion to approve the meeting minutes with 2nd motion by Jason (Lewis and Clark). Meeting minutes were approved unanimously.

3. Treasurer Report - N. Gray

- No changes to the bank account balance at \$13,739
- Invoices went out to clubs
- When send back emails to the board please include "signature line" with club name so invoices and payments can be tracked

4. IOLA

- They would like to add per diem to overnight referee stays. Will add some cost to clubs this year but shouldn't be a lot.
- Waiting on final invoice and contract from IOLA and will bring to January meeting

5. Missoula Cross-Divisional Weekend (April 17-19)

- The weekend may be in question due to lack of fields. Missoula has 1 field (turf) reserved but won't know on the other 3 until March
- Difficulties with getting this weekend scheduled for the North region along with all regular season games before Regional weekend
- East is willing to go to Missoula
- Feedback from clubs is to pursue it

6. By Law Changes- Updated Language and Vote - Matt

- By-law changes were reviewed and opened up for period of additional input
- Put to a vote with 15/15 present voting members voting "yea" for unanimous approval of by-law changes.

7. State Tournament Host Proposals

- Charles(Rexburg) announced that their club will officially put in a bid to host the state tournament.
- Jackson Hole/Rexburg are also interested in hosting
- Proposals will be presented at next meeting for club input and vote

8. Registration Costs Update

- No update to cost for clubs this year

9. East/ North Season Scheduling Update

- North schedule is almost completed now that the Missoula weekend looks like a go
- North has 6 games left to schedule
- East- Heather Frei not present but other members of the East report that their schedule is almost complete as well
- East needs to confirm that Bozeman got all their games scheduled play each team twice for fair regional seeding.

10. Rules in Policies

- Commissioner brought to the attention of the members that there is a rule under “policies” about a player needed to play in 6 varsity regular season games in order to be eligible for post-season play.
- Concerns are if this is “needed” as see the potential for injury early in the season but back for post-season play.
- Most members felt it was not needed and will bring to vote at next meeting

11. NW Avalance and Bozeman would like information and training about how to do STATS and Rostering

- Natalie Gray- Treasurer will send out information on how and where to complete stats
- Natalie will send out excel spreadsheet for teams to complete rosters and she will input them into the system for each team.

12. Potential By-Law change -8th Graders

- Concern posed by Cori (Lake City) about the club language around the use of 8th grade players. Currently states “up to the discretion of the local club”
- Recent incidence at a jamboree have raised concerns about where the GWLL stands on this issue.
- Discussion around the topic was had that included
 - At JV level only
 - Do we then have to limit where seniors can play?
 - Is there language at USA Lacrosse for guidance?
 - Not allowed at all at the varsity level ?
 - The conclusion was to add some language around it that is at the discretion of the eligibility committee and Ricky will work on the language and present it for approval and vote at the next GWLL meeting.
