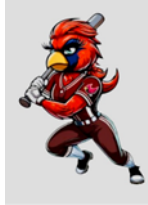

 - **Old Business** – Nothing to discuss.
 - **President Update** - Evaluations are next Monday, 3/2 at ARCC. To date, we have: 8U – 16 players registered so far; 10U – 14 registered; 12U - 15 registered; 14U - 2 HS – 10. Multiple emails have been sent and numerous FB posts. Registration ends Sunday 3/1. Aware of additional players still needing to register at all levels. Will be reaching out to neighboring associations for some levels to check on their numbers. Evaluations: Brian from ARCC helping for \$500 along with 8 of his people. Cole made motion and Brian 2nd. Motion passed. They want to run the 8U thru so they know what to expect next year. 8U @ 5:30. 10U arrive at 6, start at 6:30, 12U arrive at 7, start at 7:30. 14U will eval with 12s. Uniform orders being submitted on Weds. Everyone must do sizing at evaluations. If HS players are not doing evals, they can send in their sizes or come up and try on.
