

**7 Elite Academy Disneyland Tickets Tryouts Registration Giveaway
Terms and Conditions**

ELIGIBILITY: The 7 Elite Academy Disneyland Tickets Tryouts Registration Giveaway (the “Giveaway”) is open to residents of Utah aged 18 and over. Employees of 7 Elite Academy, and its parent companies, subsidiaries, affiliates, and immediate family members, as well as additional participating parties, vendors, advertising, promotion agencies, or freelance contributors to 7 Elite Academy are not eligible to enter or win the Giveaway.
