DOG ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), **an AKC Canine Partners listing number**, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four months of age are strictly prohibited from the trial grounds. Deaf dogs ARE allowed to compete.

Team Class, Scoring. Individual dogs' scores will be based on the performance of the dogs and handlers individually plus team precision and coordination. Each dog and handler will be scored against the customary maximum for a team total of 800 available points. Individual dogs' scores need not be recorded.

The exercises and maximum scores in the Team class:

1. Heel on Leash and Figure Eight 160 points
2. Stand for Examination 120 points
3. Heel Free 160 points
4. Drop on Recall 120 points
5. Sit Stay – Get Your Leash 120 points
6. Group Exercise – Sit & Down Stay 120 points

Maximum Total Score 800

Brace Class. The Brace class will be for two dogs of the same breed or two dogs listed with AKC Canine Partners of similar height at the withers that are eligible under these regulations and capable

of performing the Novice exercises. The dogs need not be owned by the same person but will be handled by one handler. Dogs may be shown unattached or coupled (the coupling device will not be less than 6 inches in overall length). Whichever method is used will be continued throughout all exercises. A separate official entry form will be completed in full for each dog entered. Exercises, performances, and judging will be as in the Novice class. The brace should work in unison at all times. Either or both dogs in a brace may be entered in another class or classes.

ENTRY FEES PER DAY

The first entry for each dog in each trial, Obedience and Rally, is \$20.00. Each additional entry for the same dog in the same trial is \$15.00. **Please remember, the Obedience and Rally trials are separate events.**

Entry fees include the AKC \$50 Recording and \$3.00 Event Service fee for Obedience and a \$3.50 recording fee for the first entry and \$3.00 for each additional entry of the same dog in Rally.

Non-Regular Classes are \$15.00 per entry per trial. \$15.00 for both dogs in brace and \$15.00 for all four dogs in team.

Returned checks do not constitute a valid entry. A \$25.00 fee will be charged for a returned check.

RIBBONS, AWARDS, AND PRIZES

A qualifying score is required for all prizes in Regular, Optional, Alternative and Rally Classes. A dark green qualifying ribbon will be given to each dog attaining a qualifying score in the Regular, Optional, Alternative and Rally Classes. Placement rosettes will be awarded in all Regular, Optional, Alternative and Rally Classes. Placement ribbons will be awarded in all Non-Regular classes. New Title ribbons awarded for Obedience and Rally. All prizes will be awarded the day of the Trial none will be mailed. Prizes not claimed at the Trial become the property of FFDTC. "Dog" means either sex. All prizes are offered each day by Five Flags Dog Training Club unless otherwise indicated.

COVID INFORMATION

FFDTC will be following state and local guidelines for this trial and we expect all exhibitors to comply as well. By entering this trial, you are agreeing to abide by these guidelines set by the club and guidelines set by the state and local governing bodies. For exhibitors that have others traveling with them, but are not entered in the show, they are also expected to abide by these guidelines.

1. Exhibitors, workers and spectators at the trial will wear a mask when it is not possible to maintain adequate distance from others. Masks will be worn while walking the course but may be removed when you run your dog.
2. Maintain 6 feet of space between crating areas. You may also crate out of your vehicle or you may rent a stall.
3. Hand sanitizer will be available so exhibitors and workers and clean their hands frequently. Exhibitors are encourage to bring their own hand sanitizer as well.
4. If you are ill, please stay home! If you have been exposed to someone that has tested positive for COVID-19 in the past 14 days, please stay home.
5. Failure to adhere to these guidelines could excuse you from the trial without a refund.

NOTICE TO EXHIBITORS

Illegible entries will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Trial Secretary will add a **\$25.00** collection fee to the amount of each returned check.

ENTRIES close Wednesday January 13, 2021 at 4:00 pm. All entries must be on an AKC Official Entry Form and must include the Agreement and Instructions on the reverse side. Entries will not be accepted without the proper form, signature, fees, or if the entry specifies any condition as to its acceptance. Incomplete, inaccurate or illegible entries will not be accepted. Telephone, email, or faxed entries will not be accepted. Selected trials must be checked or circled. All American Dogs that are listed with AKC Canine Partners may participate provided their listing number has been recorded on the entry form. Please note there are separate entry forms for Obedience and Rally. Please type or print legibly.

LIMITS: Saturday and Sunday entries will be limited in accordance with Chapter 1of the AKC Obedience and Rally Regulations. Entries will be processed in the order received and time limits calculated for each judge until the daily judging limit is reached or entries close. Obedience UDX and Rally RAE Class entries will be given priority.

JUMP HEIGHT: All classes requiring jumps will be arranged in jump height order. Saturday and Sunday judging will begin with the 4 inch jump height and continue in ascending order. If you are entering any of these classes jump height is a required part of your entry. Please refer to AKC Obedience Regulations for the description of classes, eligibility, and proper jump heights.

ERRORS ON ENTRIES: Owners are responsible for the accuracy of the information required on the entry form. Changes, additions, or corrections to an entry, entry substitutions, or cancellations by the owner must be received in writing by the Trial Secretary prior to the closing date of the trial. Other means of notification will not be accepted.

REFUNDS: All requests for the refund of Trial or Match entry fees must be received before the closing date. A refund of entry fees will not be given in the event a dog is absent, disqualified or excused by a veterinarian or judge, or barred from competition by action of the Trial Committee; or if the trial cannot be opened or completed by reason of riots, civil disturbances, extreme and/or dangerous weather conditions, or any emergency or other cause beyond the control of the Club.

Entry fees, less a \$10.00 per trial processing fee, will be refunded for bitches that come in season after the closing date. A written refund request from the owner accompanied by a signed and dated verification from a veterinarian must be received by the Trial Secretary no later than one hour prior to the start of the first class in the trial. Bitches in season are not permitted at the show site at any time.

TRANSFERS: Transfers are permitted in accordance with Chapter 1 of the AKC Obedience and Rally Regulations. A request for a Transfer must be in writing and given to the Trial Secretary at least 30 minutes prior to the start of each trial. Transfers prior to the day of the Trial will be accepted. Forms will be available at the Trial Secretary's table.

RALLY RING: The Rally ring will be 40 x 60 feet.

JUDGING: The Judging Program will be sent to exhibitors approximately one week prior to the Trial. Judging schedule conflicts should be resolved with the judge at the trial, at least 30 minutes prior to the start of the class.

It is the exhibitor's responsibility to be ringside ready to enter the ring when called. Neither the Trial Secretary nor the stewards are obligated to notify any exhibitor when they are due in the ring for judging. Judges are not required to wait for any exhibitor. Dogs need be present only for scheduled judging and will be released if not needed for further judging.

SHOW SITE: All dogs must be held on a leash or confined to a crate except when in the ring for judging. Dogs must be on a leash when being exercised, trained or when warming-up. Please maximize available crating space but **do not crate within 10 feet of the ring gates.** Dogs must be removed from the building immediately following the end of the Trial. FFDT reserves the right to remove any dog in distress in a parked vehicle or crate.

Please keep the grounds clean by picking up after yourself and your dog. An exercise area outside the facility will be plainly marked. Use this area only and dispose of "poop bags" in the trash containers provided there. Please keep your crating area, the trial site, RV grounds, and motel rooms and grounds clean so we may continue to be welcomed at these facilities.

CONDUCT TRIAL/MATCH: It is expressly understood that all owners/agents/exhibitors are solely responsible for the behavior of their dogs and/or children. Any person(s) whose dog and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior will be asked to leave the trial site. In such cases the Club will not refund any fees or monies previously paid.

Owners/agents/exhibitors engaged in conduct prejudicial to the best interests of the Sport of Obedience, AKC events or the AKC will be asked to leave the trial site or brought before the Event Committee depending upon the seriousness of the offense. In such cases the Club will not refund any fees or monies previously paid.

All owners/agents/exhibitors and other persons attending these trials hereby waive any claim against the Club or its agents, for any losses, damages, or injuries affecting self, dogs, children, or personal property.

WARM-UPS and training should be conducted in accordance with Chap 2 of the AKC Obedience and Rally Regulations.

CATALOGS: Trial catalogs are available by advanced sale only for \$10.00. Please indicate the payment on your entry form and include fee. Catalogs will not be sold at the trial.
