

# In The Crease Membership: Bulldog Club -Membership Agreement

Terms and Conditions for Annual Membership Paid Monthly

## Introduction

This Monthly Membership Agreement ("Agreement") sets forth the terms and conditions for participants enrolling in the In The Crease Membership: Bulldog Club ("Membership"). By completing the Bulldog Club Membership registration on the In The Crease website ([www.itcgoaltending.com](http://www.itcgoaltending.com)), the applicant ("Member") agrees to abide by all policies outlined herein for the duration of the Membership term.

## Membership Overview

- The Bulldog Club Membership is an annual program designed for goaltenders seeking exclusive benefits with In The Crease.
- The cost of Membership is \$468 per year, billed in monthly installments of \$39.
- Monthly payments will be charged automatically on the first day of each month.
- This Membership is a yearly commitment, with payments divided into twelve equal installments.
- Early termination or cancellation of Membership is not permitted. Members are responsible for the full annual payment, even if paid monthly.

## Membership Term and Renewal

- The Membership term commences on the date of sign-up and remains active for one full calendar year.
- At the end of the one-year term, Membership will automatically renew for an additional year unless cancellation is requested by the Member.
- Cancellation requests must be submitted via email prior to the renewal date to avoid automatic renewal.
- Cancellation requests can be sent to the designated In The Crease contact email address, as listed on the official website.

## Payment Terms

- Members authorize In The Crease to automatically charge \$39 to their designated payment method on the first of each month.
- The total annual Membership fee is \$468, spread across twelve monthly payments.
- Payments are non-refundable, including in the event of early termination or cancellation by the Member.
- Failure to make timely monthly payments may result in suspension or termination of Membership benefits.

## Membership Benefits

- Members receive a 10% discount on all In The Crease camps and clinics.
  - The discount does not apply to private lessons or other services not specified as camps or clinics.
  - Each Member will be assigned a personalized discount code upon registration.
  - This code is unique to the Member and may only be used by the Member for their own registration.
  - Sharing, distributing, or allowing another individual to use the personalized code is strictly prohibited.
  - Misuse of the discount code may result in immediate termination of Membership without refund.
- Each Member is entitled to two free private lessons per year (valued at \$200 each):
- One (1) lesson with Timm Lorenz
- One (1) lesson with Mark Sample
  - Free private lessons must be scheduled directly with the respective coach.
  - Lessons must take place during designated private lesson times at the Sport Stable in Superior, CO.
  - Unused lessons expire at the end of the Membership term and do not roll over to future years.
  - No substitutions or exchanges are permitted for the free lesson benefit.
- Members receive two (2) promo cards from Pure Hockey worth a value of \$100 each.
  - Each promo card will be active for the duration of one week, with the active dates 6 months apart.

## Membership Activation

- Membership becomes active immediately upon successful registration and processing of the first monthly payment.
- Members will receive confirmation of Membership activation and details regarding their personalized discount code and private lesson scheduling.

## Annual Renewal and Cancellation

- At least thirty (30) days prior to the annual renewal date, In The Crease will provide notice of upcoming automatic renewal.
- Members wishing to cancel prior to renewal must send a written cancellation request by email.
- Cancellation requests submitted after renewal will result in Membership remaining active for the new annual term, with payments required for the full year.

## Termination of Membership

- In The Crease reserves the right to terminate Membership at any time, for any reason deemed appropriate by In The Crease management.
- Termination by In The Crease may occur for reasons including, but not limited to, violation of this Agreement, misuse of benefits, or inappropriate conduct.
- No refunds will be issued for Memberships terminated by In The Crease.

## Additional Terms

- All Membership benefits, including discounts and lesson entitlements, are valid only during the active Membership term.
- Benefits may not be transferred, shared, or assigned to any other individual or party.
- Members must comply with all In The Crease policies and procedures when attending camps, clinics, and lessons.
- In The Crease reserves the right to modify Membership benefits and terms at its discretion. Notice of any changes will be provided via email or posted on the official website.

## Acceptance of Terms

By completing the Bulldog Club Membership registration and submitting payment, the Member acknowledges and agrees to all terms and conditions described in this Agreement. Membership in the Bulldog program is a privilege, and continued participation is contingent upon adherence to the guidelines and conduct expected by In The Crease.
