A little later on Monday, I received an email from a different Association advising me that one of their 10U B teams no longer exists. After having spent 30 plus hours on these tournaments, I set out to redo them. On Friday afternoon, I received an email from yet another Association stating they will not be sending an 18U B team to State. I will be redoing this tournament schedule. Since the 18U A and 18U B schedules work with each other, I did not have time to redo the schedule and get ice confirmations so I will not be presenting these schedules today.

Having said this, I am making the following motion: I move to give Carol and Lacey the authority to approve the final schedules for the 18U A and 18U B State Tournaments.

I move to approve these schedules and for Carol to finish placing the teams on the schedules as the League play finishes and the seeding is established.

12U A Juneau goes to Jr Avalanche
14U A AHA goes to Homer
18U A and 18U B AHA goes to Fairbanks
10U B Kodiak goes to AHA
12U B Juneau goes to AHA
14U B Delta goes to Mustangs

Also, please make sure that the trophy is passed off in good shape with no loose or broken parts and is clean.

The three Associations that have canceled their teams participation in State Tournaments have been advised that they have a \$1,000 fine and that their tournament fee is added to the fine. That the fee must be paid by October 1st to be in "good standing" with ASHA. Per ASHA Handbook section 8.16.1

I am looking forward to working with the Host Associations to accommodate the 87 House teams and 47 Comp teams that have entered State Tournaments.
