This **Field Rental Agreement** ("Agreement") is made by and between the **Liberty Hill Youth League (LHYL)** and the individual or organization identified below ("User"), for the rental and responsible use of LHYL softball field facilities.

  2. **Full payment** of rental fees has been received;
  3. A **confirmation email** has been issued by LHYL.

**FIELD USE POLICIES & RULES**

To ensure the safety, cleanliness, and proper maintenance of our facilities, all Users agree to the following **LHYL Field Rules**:

1. Fields are designated **exclusively** for **Softball and/or Baseball activities**.

2. **Rental time includes setup and cleanup.** Use must begin and end at your scheduled times.
  3. User is responsible for **leaving the field and adjacent areas clean** and in the same condition as prior to use. All trash must be picked up and disposed of properly.
  4. Use is **restricted to the field reserved.** Warming up or practicing on other fields is not allowed.
  5. **Climbing on or over fences is strictly prohibited.**
  6. **Restrooms and concession stands are closed during the offseason.**
  7. **No pets or animals** are permitted on the field or in dugouts.
  8. All equipment brought by the User must be **removed immediately** following use.
  9. User must **rake and level the field** after use, including the batter's boxes, catcher's area, pitcher's mound, and any low spots.
  10. Before leaving, the User must **turn off all field lights, close, and lock all gates.**
  11. **Violation of any rule may result in immediate removal** from the facility and **revocation of future rental privileges.**

## **WAIVER & INDEMNIFICATION**

In consideration of the use of LHYL facilities, the User agrees to **hold harmless and indemnify** Liberty Hill Youth League, its directors, agents, volunteers, and employees from and against any and all **liability, loss, claims, damages, or expenses**, including legal fees, arising out of or related to any activity or conduct of the User, its participants, agents, or invitees during or in connection with use of the facility.
