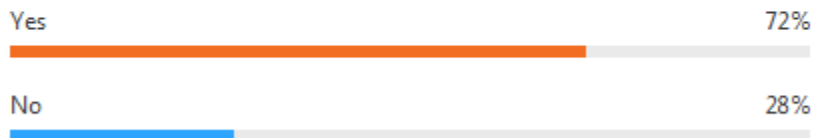
Ryan Gass proposed we set dates and make schedules and plans to proceed. We may never get to the point that we get to games. It may be a summer of just practices.

1. Approve league and start practices mid-June

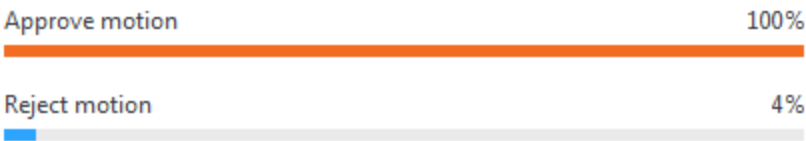


Ryan Gass motioned to set a deadline of 11:59 p.m. May 31 for members to cancel their plans to participate and get a full refund.

Darin noted that we will need to set up a meeting with coaches so that they clearly understand their expectations.

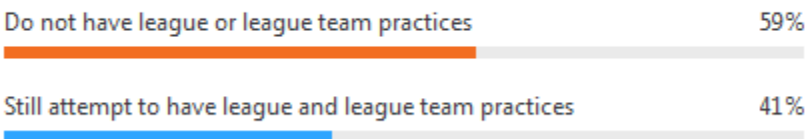
League commissioners could set up the coaches meeting for Monday (at that point we should know what our numbers are looking like).
