Minutes:

- Concession stand net profit of \$2k as of right now, in line with last year. Probably another couple hundred in Venmo yet to hit bank account
- Big April rec expenses of Uniforms and Equipment (baseballs/catchers gear)
- Big May travel expenses for tournaments (two Aberdeen payments of \$2k each, plus Memorial Day tournaments).
- Scoreboard repair of \$1,250, but will come down some as we get taxes taken off invoice - working with Daktronics for refund.

Travel Update:

- Memorial Day Tournaments went well. 11U went to semifinals. 9U went to quarterfinals. 10U went to quarterfinals.
- Districts are coming up. Only team not participating is 11U.
- Hosting 9U districts. Volunteers from 9U team. Saturday June 15th – Wed 26th. 6 teams playing each day. Jacob will work on developing entry fee for teams. Need Trophies for districts.
- Hosting 14U States. Dates to be determined.
- Need State and District 7(Cal Ripken) shirts. Order in advance.

Rec Update:

- Rec season is coming to a close. Playoffs will start soon.
- **Rookies Feedback.** Kevin will send out a request for feedback from the teams in Rookies, specifically around the new rules.

Coaches Picnic:

- Rob will send out dates for the picnic.

- **14U Banquet.** Banquet being held June 21st at Circle Lanes. Budget is covered through the Superbowl fundraiser and the approximate \$600 made so far on the team store. Board approved supplementing the banquet with the team store funds.
