

COVID-19 Liability Release Waiver

The World Health Organization has declared the novel Coronavirus (COVID-19) a worldwide pandemic. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregations of groups of people.

The Utah County Football Conference, Inc. dba Utah Youth Football Conference and its District members (both collectively and as applicable to your membership to your applicable District, "Conference") has put in place preventative measures to reduce the spread of COVID-19; however, the Conference cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, participating or attending Conference activities, including but not limited to, practice, team meetings, parties, film sessions, games, etc. ("Activities"), could increase your risk and your child(ren)'s risk of contracting COVID-19.

You and your child(ren)'s participation and attendance at an Activity is voluntary. Further, you and your child(ren) are required to abide by directives designed to lower the risk of COVID-19 exposure which may include wearing masks, social distancing (6 feet apart), washing hands, non-sharing of equipment, wiping down all shared equipment after each use, limitations on spectators, etc. These directives will be provided to you by the Conference. If you fail to follow these directives, you will forfeit you and your child(ren)'s right to continued participation in the Activities.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending the Conference Activities and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at Conference Activities may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Conference employees, volunteers, and program participants and their families. I also acknowledge that I will prevent my child(ren) from participating in activities, practices, or games if my child(ren) has been diagnosed as positive for COVID-19 or been in contact with an individual that has contracted COVID-19.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at the Activities or participation in Activities ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the Conference, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Conference, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Conference Activities.
