# Sporting Columbia Payment Policy

## **Payment Due Dates**

Failure to meet any payment due date automatically disqualifies each delinquent player from participating in team activities, including practices, league / tournament play. Upon notification from the Club, coaches shall be responsible for holding the player pass and ensuring players do not participate in any Club related events until they have received payment confirmation notice from the Club.

## **15-Day Grace Period**

Players may continue to practice with the Club after the payment due date, until the 1st day of the following month. If payment is still delinquent after the first day of the following month, players will no longer be permitted to practice with the Club until the payment obligation is met.

## **Special Circumstances and Payment Terms**

The Club realizes that special circumstances may exist from time to time, making it difficult for players/parents to meet their payment obligations. The Club Executive Director and Bookkeeper shall have the authority to negotiate special payment arrangements with player/parents, whereas players may continue to play with the Club so long as the negotiated obligations are met. The Club Executive Director and Bookkeeper do not have the authority to reduce or remove payment obligations without Board consent. All requests should be submitted to the Executive Director via email.

## **Notifications to Parents and Players**

The Club, including the Board of Directors and Bookkeeper is responsible for notifying players/parents of late payments and informing them of the Club's payment policy. Coaches and manager are jointly responsible for communicating the Club's policy and ensuring that players do not play or practice if applicable.

## **Financial Aid**

The Club offers financial aid funds for players/parents on an "as needed" basis. Those interested in applying for financial assistance must complete a Sporting Columbia SC Financial Aid Request Form. Forms must be submitted by the deadline with the supporting documents. Form available on our website.
