◆ On-line/paper registration opens

February 6, 2020

- ◆ Spring 2020 contract ice – **If you wish to make payments on your SPRING contract you must submit a paper contract** (emailed/scanned/front desk drop off) and the sessions will be added to your account – Reminder that on-line registrations happen in real time and paper registrations are processed during office hours. Potentially a session could fill through on-line registration prior to the paper application being processed.

You will receive a confirmation via email once the paper contract has been processed. Paper contracts turned in prior to the open registration date will be returned. Spring 2020 contracts will not be processed until Winter 2019/2020 contract has been paid in full. Sessions are filled on a first come basis.

1st payment due NO LATER than February 23, 2020 @ 11:59p– if a session is full with a waitlist you will be removed from that session if payment is not received by February 23, 11:59p. Your contract spot will be open for the next skater on the waitlist.

◆ VOLUME PURCHASE PROMOTION

The FREE session is an additional session you will select AFTER you have contracted for your winter ice time. This free session will not replace one that you are already paying for. Valid per INDIVIDUAL skater. If you are registering on-line you must EMAIL the free session(s) to aleik@superrink.org

Do NOT add this session to your cart when registering on-line or the system will have you pay for it.

◆ RANDOM SESSION PRICES – Skaters are welcome to buy-on to any freestyle that has openings

30 minute freestyle - \$10.50

45 minute freestyle - \$14.50

Two hour morning block - \$15

COMPETITION / USFS TESTING CONFLICT

If you are going to miss a contracted session(s) due to a skating competition/USFS test session you will be allowed to receive random coupon(s) to use during the SPRING 2020 contract for your missed session(s). Submit a copy of your official competition/test time(s) from the competition/test session to Anna Leik **no later than ONE WEEK** prior to the competition/test. There must be a direct conflict with your competition/test time and your contracted session to receive the coupon.

CHANGING/CANCELLING SESSIONS ~ INJURY OR ADDING SESSION

Injury ~ If you need to cancel due to an injury, a doctor's note must be submitted with your request for a refund or credit. Refunds or credits will only be issued if your injury keeps you from skating more than one week. The first notification on file must be to NSC within 72 hours of the first date requesting the contract credit. A doctor's note is required within five days of the first date requesting a credit. Your ice time will then be placed on the cancellation list for the duration of the injury request.

Adding Sessions ~ No late fee will apply if you add additional sessions after the contract due date. Contract will be processed at the date the changes/additions are made. Any changes to your original contract must be submitted in writing.

Cancelled Session ~ If a session is cancelled by NSC due to low enrollment you will be notified immediately.

Switching Sessions ~ Skaters will be allowed to switch contracted sessions to a different session on the **same day** (if there are random open spots). If you are switching from a session that is not the same length of time there will be a fee listed to do so. There will not be a credit given if you switch from a longer to a shorter length session.

Stop Skating/Cancel Contract ~ If a skater stops skating or wants to cancel their contract during the current contract session, they will be responsible for payments for all the ice skated and all future ice will be cancelled once notification is received. The notification must be made via email with the final skating date listed. A \$100 cancellation fee or the remaining ice payments (whichever is less) will be required to close out an ice skating contract account.

Drop/Switch sessions ~ When a request is made to drop/switch a session(s) after the start of the contract, there will be a \$25 processing fee per change request.
