### **New Business:**

1. State Board Meeting Update: no changes for the upcoming season, except for friendly games. If you have 3 team friendly playin, the games have to be registered as tournament play through USA Hockey (\$300). Coaching clinics will be done online or in Utah.

2. Changes to Policies and Procedure - Bill updated

- a. Selection of division head coaches. The Coach in Chief would be selected by the Director. The Coach in Chief or someone appointed by the President and Division Director would meet to select the Division Head Coach. If an agreement cannot be reached regarding the selection, the selection will be made by the President.
- b. Off ice training for 3 coaches per division each year.
- c. End of year meeting with Directors and Parent Reps to set expectations for the coming year.
- d. 2nd division enrollment - price reduced to \$150
- e. A person assigned to providing information about getting players to the next level.
- f. Creating an alumni association.
- g. Delegating responsibilities of the President. (Treasurer, Safe Sport Coordinator, Registrar, Ice Scheduler, Development Coordinator, Etc.)
- h. U12 and U19 girls should not combine practices.
- i. Paid coaching (1-reimbursement at least for registration fees if no relation to player: 2-reimbursement for travel expenses for coaches w/no relation to player)

Bill will put the proposed changes in writing and formally present them to the board.

3. Film - hudl / assist - Silver package \$2500 per team (100 hours of film)  
Assist w/2 non assist accounts \$8500

Powerplayer - software that tracks skills per player \$29.99 per player
